Re: **SANDAG BOARD MEMBERSHIP (District - All)**

At yesterday's City Council meeting, the City Council was unable to reach agreement on the appointment of a new primary member to the Board of Directors of the San Diego Association of Governments and did not vote on the appointment of new alternate members to the board.

Resolution 2022-015 (attached), adopted by the City Council on January 11, 2022, confirmed the appointment of former Mayor Hall as the primary member, Council Member Bhat-Patel as the first alternate member, and then Council Member, now Mayor, Blackburn as the second alternate member. The resolution specified the appointments would be "for a term ending in December 2022 or until replacements are appointed." (Emphasis added.)

As former Mayor Hall is no longer an elected official, he is not eligible to serve on the board. However, Council Member Bhat-Patel remains the first alternate member and Mayor Blackburn remains the second alternate member until replacements are appointed or the City Council votes to recall them.
