About the Palomar Airport Advisory Committee

The San Diego County Palomar Airport Advisory Committee advises the San Diego County Board of Supervisors and the County Chief Administrative Officer on matters related to Palomar Airport, in accordance with the following Committee duties and responsibilities:

- To review and make recommendations on issues pertaining to noise control at Palomar Airport.
- To review and make recommendations regarding land use within the Airport influence area.
- To review and make recommendations regarding issues pertaining to the development and operations of Palomar Airport.
- To provide an open forum between the Communities and the County on matters pertaining to Palomar Airport.
- Any other items as may be assigned to the Committee by the Board of Supervisors.

Requirements to Serve

The City of Carlsbad is seeking applications from Carlsbad residents to serve on the County of San Diego's Palomar Airport Advisory Committee. Upon selection by the Carlsbad City Council, the preferred applicant(s) will be presented as a candidate(s) for the Supervisor from the Fifth Supervisorial District to consider for nomination to the Board of Supervisors. Appointment of the city's preferred candidate(s) will require the approval of the San Diego County Board of Supervisors.

Each member of the Committee shall serve a term which shall run concurrently with the term of the Supervisor who nominated them to the committee. The term shall expire on the date of expiration of the term of the nominating Supervisor, or at such time as he or she ceases to hold office, whichever first occurs. The reelection of the nominating Supervisor for a succeeding term shall not automatically extend the term of any Committee member.

Members of the Committee shall serve without compensation and shall not be reimbursed for expenses incurred in performing their duties.

As this will be an appointment to a County of San Diego Committee, candidates may be asked to provide additional information. Membership qualifications for all County Boards, Commissions and Committees may be accessed through the San Diego County Clerk of the Board's website at www.sandiegocounty.gov/cob/bcac/ or by calling (619) 531-5600.

- Applicants are encouraged to schedule meetings with members of the City Council to discuss their interest and qualifications relating to their desire to serve on the Palomar Airport Advisory Committee.
- Applicants are invited to attend the July 11, 2023, City Council meeting where the selection of a
 preferred applicant will take place to provide their qualifications and answer any questions asked
 by members of the City Council. Attendance by the applicant at this City Council meeting is
 voluntary and not a requirement for appointment.
