

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN to you that the Planning Commission of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5:00 p.m. on Wednesday, **July 19, 2023**, to consider a request for the following:

CASE NAME: CDP2021-0011, HMP2021-0002 - City of Carlsbad Beach Access Repairs Project

PUBLISH DATE: July 7, 2023

DESCRIPTION: Request for the approval of a Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program and approval of a Coastal Development Permit and a Habitat Management Permit to allow for structural repairs and improvements to the existing concrete sidewalk, retaining walls, and beach access stairways located along the western area of Carlsbad Boulevard and the Beach Promenades from Pine Avenue to Tamarack Avenue. The Project includes widening the upper sidewalk ranging from 9-feet to 11-feet-10-inches. The sidewalk between Pine Avenue and Maple Avenue will be extended via a cantilever and use the existing footing. The sidewalk between Maple Avenue and Cherry Avenue will be extended by removing a metal Beam and expanding the sidewalk on grade. Five beach access stairways between the upper and lower sidewalks will be replaced and upgraded. Other improvements include the replacement of existing streetlight poles, railing around the beach tower, and sidewalk overlooks. The Project site is located within the Mello II Segment of the Coastal Zone and is appealable to the California Coastal Commission and is within Local Facilities Management Zone 1. Mitigation measures included to reduce environmental effects to less than significant are included for Biological Resources, Geology and Soils, Hazards and Hazardous Materials, Noise, Cultural and Paleontological Resources, Transportation, and Tribal Cultural Resources.

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project. Copies of the staff report will be available online at https://www.carlsbadca.gov/city-hall/meetings-agendas/boards-commissions/planning-commission on or after the Thursday prior to the hearing date.

VISUAL MATERIALS FOR PLANNING COMMISSION: Visual materials should be submitted to the Planning Division at 1635 Faraday Avenue no later than noon on the day of a Regular Planning Commission Meeting. Digital materials will be placed on a computer in Council Chambers for public presentations. Please label all materials with the agenda item number you are representing. All materials exhibited to the Planning Commission during the meeting (slides, maps, photos, etc.) are part of the public record and must be kept by the Planning Division for at least 60 days after final action on the matter. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City of Carlsbad at or prior to the public hearing.


Appeals to the City Council: Where the decision is appealable to the City Council, appeals must be filed in
