

### **NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN to you that the Planning Commission of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5:00 p.m. on Wednesday, **August 16**, to consider a request for the following:

**CASE NAME:** **CDP2023-0018 – East and West Corridor Road & Pedestrian Improvement Project**

**PUBLISH DATE:** August 4, 2023

**DESCRIPTION:** Request for the approval of a Coastal Development Permit to allow for the reconfiguration of Poinsettia Lane between Carlsbad Boulevard and Avenida Encinas and Tamarack Avenue between Sunny Hill Drive and El Camino Real. The project will add a large buffer to the existing class II bike lanes by restriping vehicle lanes in this area from four to two through-vehicle lanes, while maintain the same number of dedicated turn lanes at intersections. Traffic studies show the lane reconfiguration for this segment will still operate under acceptable levels of service under the city’s General Plan Mobility Element. The City Planner has determined that the project is categorically exempt from the requirements of the California Environmental Quality Act (CEQA) pursuant to section 1301(c) Class 1 Existing Facilities.

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project. Copies of the staff report will be available online at <https://www.carlsbadca.gov/city-hall/meetings-agendas/boards-commissions/planning-commission> on or after the Thursday prior to the hearing date.

All materials exhibited to the Planning Commission during the meeting (slides, maps, photos, etc.) are part of the public record and must be kept by the Planning Division for at least 60 days after final action on the matter. Your materials will be returned upon written request. **Video clips cannot be accommodated.**

### **APPEALS**

The time within which you may judicially challenge these projects, if approved, is established by State law and/or city ordinance and is very short. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City of Carlsbad at or prior to the public hearing.

- Appeals to the City Council:** Where the decision is appealable to the City Council, appeals must be filed in writing within ten (10) calendar days after a decision by the Planning Commission.
- Coastal Commission Appealable Project:**
  - This site is located within the Coastal Zone Appealable Area.
  - This site is not located within the Coastal Zone Appealable Area.
  - Application deemed complete: May 8, 2023

Where the decision is appealable to the Coastal Commission, appeals must be filed with the Coastal Commission within ten (10) working days after the Coastal Commission has received a Notice of Final Action from the City of Carlsbad. Applicants will be notified by the Coastal Commission of the date that their appeal period will conclude.
