SUBJECT: DETERMINATION OF THE CITY PLANNER TO ALLOW "ESCAPE ROOMS" AS A RETAIL USE

Dear Mr. Mikusky:

The Community Development (CD) Department is in receipt of your letter dated July 28, 2023, requesting a determination of experiences known as "Escape Rooms" are within the classification of "Retail Use" as allowed within Planning Area 6 of the Carlsbad Ranch Specific Plan for the Carlsbad Premium Outlets. The site and requested use are subject to the following regulations:

General Plan - The property is designated as a Regional Shopping Center in the city's General Plan.

<u>Carlsbad Municipal Code</u> - The property is designated C-2-Q, General Commercial in the Qualified Development Overlay Zone. The C-2 General Commercial uses are further limited by the Specific Plan, and the restrictions for the Qualified Development Overlay Zone are included in Section 21.06.010 in the Carlsbad Municipal Code. The Site Development Plan and Carlsbad Ranch Specific Plan are consistent with these requirements.

<u>Carlsbad Ranch Specific Plan</u> - The property is within the Carlsbad Ranch Specific Plan, Planning Area 6, Specialty Retail. The Permitted uses within the specialty retail area includes several types of uses on Page 156 of the Specific Plan. Uses allowed include "retail business uses" and "other retail services and administrative uses, except new or used car sales, determined by the Planning Director to be consistent with the general character of the above listed uses." This is similar with authority granted by the CMC in 21.28.01 (C) that authorizes the City Planner to determine uses that are substantially similar to the uses allowed to an allowed use if it falls within the "intent and purposes" of the zone.

In review of the evidence submitted and the city's existing regulatory documents, and in recognition that some uses are not defined in the zoning ordinance as new types of businesses become more prevalent, it is determined that "Escape Rooms" are most similar in nature to a retail use. While there is no definition of retail in the Carlsbad Municipal Code, retail is defined as "to sell in small quantities directly to the ultimate consumer" by the Merriam-Webster online dictionary. An escape room concept is similar in scale and consistent with retail operations of various sizes that are allowed within the Specialty Retail designation of Planning Area 6 of the Carlsbad Ranch Specific Plan.

This determination may be appealed to the Planning Commission pursuant to CMC §21.54.140 within ten days of the date of this letter. Appeals must be submitted in writing to the Community Development Department; attention City Planner at 1635 Faraday Avenue, Carlsbad, 92008 along with a payment of \$900. Please be advised that the filing of such appeal within such time limit does not stay any requirements, agreements, deadlines, or enforcement action that may otherwise apply to this project or property.

Dear Mr. Jones,

Thank you for taking the time to discuss our potential opportunities at Carlsbad Premium Outlets. We have had interest from multiple parties to create an experiential and immersive entertainment space within the existing premises. These types of experiences are more commonly known as "Escape Rooms" and I have attached a brochure for one specific company, "Red Door Escape Room". Within most other jurisdictions this user operates within, the use can be classified within definition of the zoning code as a "retail" use.

As you are aware, Carlsbad Premium Outlets is located within Planning Area 6 of the *Carlsbad Ranch Specific Plan*. The Specific Plan denotes the zoning for this area as *C-2-Q (General Commercial)* on Figure 9, Specialty Retail as a Planning Area on Figure 10, and retail on Figure 12.

Page 33 of the Specific Plan further defines the proposed uses for *Planning Area 6* as defined below.

Regional Commercial

This category applies to Planning Area 6 for a specialty retail center with a regional focus. Due to its location along Paseo Del Norte near the I-5 interchange, the Specialty Retail Area is planned as a more automobile oriented retail center. This would be an appropriate location for uses such as a factory outlet center, eating establishments, commercial uses related to agriculture, movie theaters, and other similar entertainment.

The development standards and uses are further defined under Section G - Planning Area 6 - Specialty Retail. 1.a. Permitted Uses

- Retail business uses;
- Garden centers and nurseries;
- Restaurants;
- Professional, business and administrative office uses;
- Medical offices;
- Personal services, such as barbers shops, beauty shops and exercise studios;
- Other retail services and administrative uses, except new or used car sales, determined by the



Planning Director City Planner to be consistent with the general character of the above listed uses

Based on the above, it is my belief that an escape room type use would be allowed within Carlsbad Premium Outlets based on the current specific plan and zoning. This type of use does not fall within the definition of "entertainment" as defined in the *Carlsbad*, *California Municipal Code*, and is more closely aligned with a retail use classification.
