DESCRIPTION: A request to recommend to the City Council (1) the certification of a supplemental environmental impact report and the adoption of Findings of Fact, a Statement of Overriding Considerations, and a Mitigation Monitoring and Reporting Program; and (2) approval of amendments to the General Plan Land Use and Community Design Element and Public Safety Element; the Zoning Ordinance and Zoning Map; the Local Coastal Program; and the Bressi Ranch Master Plan, Green Valley Master Plan, Fenton Carlsbad Center Specific Plan, North County Plaza Specific Plan, and Westfield Carlsbad Specific Plan. The requested actions are necessary to implement programs of the adopted Housing Element, primarily to provide adequate sites at select locations proposed throughout the city to accommodate projected residential growth, and to update the Public Safety Element to comply with state law. Approval of the project will not approve any development. Any development will need separate and subsequent actions.

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project.
