This agreement shall not apply to claims, demands, liabilities or losses proved to have been caused solely by the active negligence or intentional misconduct of the city or its officers or employees. In executing this agreement, I/we accept all risks present in using the Lagoon including but not limited to risks created by the use of the Lagoon by others, or from the condition of the Lagoon surface, bottom or shoreline, except to the extent that those risks are created by active negligence of the City or its officers or employees.

- The registered owner listed on DMV Registration MUST be present at the time of purchase.
- Any powerboat 20'6" and over must first be inspected and approved.
- Permits are **NOT refundable or transferable**.
- <u>Provide a copy of the current year's registration/DMV Certificate of Number</u>, which is required for all watercraft **except** passive vessels and sailboats under 8 feet.
- All power vessels require a launch permit.
- Please obtain your launch permit <u>PRIOR</u> to applying for your City permit.

- Proof of residency required for discounted rate.
- Checks should be made payable to the City of Carlsbad.
