NOTICE IS HEREBY GIVEN to you that the Planning Commission of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5:00 p.m. on Wednesday, **January 17, 2024**, to consider a request for the following:

CASE NAME: SDP 2023-0012 / CDP 2023-0022 (DEV 2023-0061) – LEGOLAND CALIFORNIA PROJECT 2025

PUBLISH DATE: Friday, Jan. 5, 20024

DESCRIPTION: A Site Development Plan and Coastal Development Permit for the replacement of an existing "driving school" and "junior driving school" themed attractions with a new space-themed attraction located within the inner park area of the LEGOLAND California in Planning Area 4 of the Carlsbad Ranch Specific Plan on property located at 1 Legoland Drive, within the Mello II Segment of the Local Coastal Program and in Local Facilities Management Zone 13

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project. 


APPEALS

The time within which you may judicially challenge these projects, if approved, is established by State law and/or city ordinance and is very short. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City of Carlsbad at or prior to the public hearing.

Appeals to the City Council: Where the decision is appealable to the City Council, appeals must be filed in
writing within ten (10) calendar days after a decision by the Planning Commission.
