The first portion of the project will replace 562 feet of existing sewer main within the street section. The existing 8-inch pipes will be replaced with 12 and 15-inch pipes to increase the capacity of the sewer system and allow for adequate sewage flow. The increase in size is in response to resident complaints that sewer gasses can be smelled at the street level. The second portion of the project will add 50 feet of new sewer main to connect two existing sewer mains and provide system redundancy within the neighborhood, reducing system strain. The project will also include 21,000 square feet of asphalt resurfacing follow the sewer maintenance.
