Thank you Pete for forwarding these plans. It's great to see these buffered bike lanes and green conflict striping at intersections.

On Sheet 17 of "2023 Slurry Seal Project, The Crossings Drive":

- 1. I believe the labels "DWY" and "GRAND PACIFIC DR" on the west side of The Crossings Dr. should be swapped.
- 2. More importantly, I do not see any accommodation for where the Legoland bike path meets The Crossings Dr between Grand Pacific Dr and the Legoland staff entrance driveway. Currently there is a stripped crosswalk there. That crosswalk is important, it is an indication to motorists that there is a pedestrian and cyclist intersection there. Cyclists will be turning left from Crossings Dr onto the path and turning left from the path onto Crossings Dr.

On Sheet 31 of "2023 Slurry Seal Project, Calle Barcelona":

1. Similar to the above, there is no accommodation for pedestrians following the recreation trail that crosses Calle Barcelona between Woodfern Ln and El Camino Real. This is currently an unsafe situation. In practice walkers jaywalk across Calle Barcelona and as designed it isn't reasonable to expect otherwise. There isn't even a crosswalk striped across the driveway entrance to the Forum that might lead northbound pedestrians up to Woodfern, or any signage for pedestrians or cars indicating the safest option.

On Sheet 41 of "2023 Slurry Seal Project"

1. Thank you for finding room for the bike lane east bound on Faraday starting at El Camino. Very much appreciated!

I can comment on these items at the Monday meeting if needed.
