

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN to you that the Planning Commission of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5:00 p.m. on Wednesday, March 20, 2024, to consider a request for the following:

CASE NAME:

CDP 2023-0016/V 2023-0002 (DEV 2020-0134) - BEGONIA COURT RETAINING WALL

PUBLISH DATE: March 8, 2024

DESCRIPTION:

Request for a coastal development permit and variance to allow a series of retaining walls, which are currently built but unpermitted, to be kept in place with necessary structural retrofitting. The retaining walls step up the rear-yard manufactured slope, which has an inclination over 40% and has an elevation change of over 15 feet. The variance requested would allow the retaining walls to be permitted beyond the six-foot elevation limit set by the Hillside Development Ordinance

(Carlsbad Municipal Code Chapter 21.95).

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project. Copies of the staff report will be available online at https://www.carlsbadca.gov/city-hall/meetings-agendas/boards-commissions/planningcommission on or after the Thursday prior to the hearing date.

VISUAL MATERIALS FOR PLANNING COMMISSION: Visual materials should be submitted to the Planning Division at 1635 Faraday Avenue no later than noon on the day of a Regular Planning Commission Meeting. All materials exhibited to the Planning Commission during the meeting (slides, maps, photos, etc.) are part of the public record and must be kept by the Planning Division for at least 60 days after final action on the matter. 
APPEALS


The time within which you may judicially challenge these projects, if approved, is established by State law and/or city ordinance and is very short. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City of Carlsbad at or prior to the public hearing.

Appeals	to the City Council: Where the decision is appealable to the City Council, appeals must be filed in	
writing	within ten (10) calendar days after a decision by the Planning Commission.
