NOTICE IS HEREBY GIVEN to you that the Planning Commission of the City of Carlsbad will hold a public hearing at the Council Chamber, 1200 Carlsbad Village Drive, Carlsbad, California, at 5:00 p.m. on Wednesday, **April 17, 2024**, to consider a request for the following:

## CASE NAME: CT 2022-0003/CUP 2022-0014/CDP 2022-0047 (DEV2022-0063) - CARLSBAD BY THE SEA SUMMERHOUSE

PUBLISH DATE: April 5, 2024

**DESCRIPTION:** Request for a Tentative Tract Map, Conditional Use Permit and Coastal Development Permit for the consolidation of five legal parcels totaling 0.62 acres into one lot and for the development of a 35,721-square-foot multilevel professional care facility use with 19 memory/23 professional care beds, operated by the Carlsbad by the Sea Retirement Community, on property generally located south of Beech Avenue between Garfield and Ocean Street (Assessor Parcel Numbers 203-144-04-00, 203-144-05-00, 203-144-06-00, 203-144-07-00, 203-144-08-00) in the R-3/BAO zones, the Mello II Segment of the Local Coastal Program and Local Facilities Management Zone 1.

Those persons wishing to speak on this proposal are cordially invited to attend the public hearing and provide the decision makers with any oral or written comments they may have regarding the project. Digital materials will be placed on a computer in Council Chambers for public presentations. Please label all materials with the agenda item number you are representing. All materials exhibited to the Planning Commission during the meeting (slides, maps, photos, etc.) are part of the public record and must be kept by the Planning Division for at least 60 days after final action on the matter. Your materials will be returned upon written request. Video clips cannot be accommodated.

## APPEALS

The time within which you may judicially challenge these projects, if approved, is established by State law and/or city ordinance and is very short. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice or in written correspondence delivered to the City of Carlsbad at or prior to the public hearing.

- □ <u>Appeals to the City Council</u>: Where the decision is appealable to the City Council, appeals must be filed in writing within ten (10) calendar days after a decision by the Planning Commission.
- Coastal Commission Appealable Project:
  - This site is located within the Coastal Zone Appealable Area.
  - This site is not located within the Coastal Zone Appealable Area.
  - Application deemed complete: <u>Oct. 31, 2023</u>

Where the decision is appealable to the Coastal Commission, appeals must be filed with the Coastal Commission within ten (10) working days after the Coastal Commission has received a Notice of Final Action from the City of Carlsbad. Applicants will be notified by the Coastal Commission of the date that their appeal period will conclude.
