  before the item begins and will only be accepted for items listed on the agenda (not for general public
  comment at the beginning of the meeting). Group representatives have 10 minutes unless that time is
  changed by the presiding officer or the Commission.

SDP 2023-0014 (DEV2023-0078) - CARLSBAD VILLAGE MIXED USE: Adoption of a resolution recommending approval of a Site Development Plan, SDP 2023-0014, to demolish five existing commercial structures and consolidate four parcels of land into two parcels; and construct a mixed-use development consisting of 13,800 square feet of neighborhood-serving commercial within two one-story buildings, 218 multiple-family residential apartment units within two five-story buildings, and a five-story above grade parking structure on a 4.12-acre property located at 945-1065 Carlsbad Village Drive in the northwest quadrant of the city, the Village & Barrio Master Plan, and Local Facilities Management zone.
