

COVID-19 CONDUCT RULES

During this time of extraordinary circumstances, the City of Carlsbad Parks & Recreation Department has developed **COVID-19 Conduct Rules** to ensure protective measures are enforced for customers and staff.

Parks & Recreation Department staff is empowered to stop any activity which is considered harmful to the safety, wellbeing and security of customers and staff, or facilities operations. Anyone who is not following the COVID-19 Conduct Rules will be asked to comply and may be asked to leave the premises.

Multiple rules violations may also result in suspension of Parks & Recreation Department park and facility use, programs, resources and services, in accordance with the COVID-19 Conduct Rules.

We request your patience and understanding as we reopen our facilities with customer and staff safety as our first priority.

By entering the park or facility, you voluntarily assume all risks related to COVID-19 exposure.

REDUCED BUILDING CAPACITY

Parks & Recreation Department facilities will accommodate only a limited number of people during this time. You may be asked to wait outside, while maintaining 6 feet of distance between yourself and others, and wait until asked to enter.

DO YOU HAVE A FEVER? STAY HOME

Stay home if you have a fever of 100 degrees or higher, have any COVID-19 symptoms, or have been exposed to the virus within the past 14 days. **Patrons exhibiting COVID-19 related symptoms, identified by the Centers for Disease Control and Prevention, such as a combination of respiratory symptoms, fever, and shortness of breath, will be asked to leave the premises.**

FACE COVERING ZONE

To protect customers and staff, and in accordance with federal and state guidance and the County of San Diego Public Health Order, all persons two years of age or older are required to wear a face covering while indoors, and while outdoors and unable to maintain a distance of at least six feet away from others not in their household, as described and required in California Department of Public Health (CDPH) Face Covering Guidance.

Additionally: (a) for outdoor pools, face coverings are required to be worn when out of the water, as described and required in CDPH Fitness Center Guidance; (b) for playgrounds, face coverings are required to be worn by all persons two years of age or older, as described in CDPH Outdoor Playgrounds and Other Recreational Facilities; and (c) for sports, face coverings are required to be worn by all observers and participants when not in the activity, as described and required in CDPH Outdoor and Indoor Youth and Adult Recreational Sports Guidance.

If you cannot wear a face mask due to a medical or mental health condition, or a disability, request an accommodation.

PHYSICAL DISTANCING

Maintain at least 6 feet (about 2 arms' length) from other people whenever possible. The use of a face covering is not a substitute for physical distancing. Please continue to observe rules regarding appropriate distancing.

RESPECT EACH OTHER

Respect Parks & Recreation Department staff who are enforcing the provisions of the COVID-19 Conduct Rules.
