County launches small business stimulus grant program

Yesterday, the County Board of Supervisors approved a small business stimulus program using \$17 million in CARES Act funding.

For profit and nonprofit businesses can apply for grant money if they can show losses and costs that are a direct result of the pandemic.

To qualify businesses must have:

- 100 or fewer employees
- Headquarters in San Diego County
- A minimum one-year operating history as of Feb. 14, 2020
- Documented financial hardship due to COVID-19

Businesses are urged to apply early. Applications are available now through Oct. 16, subject to available funding. Funding amounts/awards have not yet been specified. For more information and the application, visit the county's <u>stimulus website</u>.

PPP loan program extended

The PPP loan has been shown to be the most effective COVID-19 relief program for small businesses. Businesses who had not applied for a PPP loan, should know that the program was extended until Aug. 8 and funds are still available. For more information, go <u>here</u>.
