1. Hauling of materials or equipment on Saturday, Sunday, or city holiday is prohibited.
2. Hours are restricted to 7:00 a.m. to 4:00 p.m., unless otherwise noted.
3. The city reserves the right to revoke or change this haul route at any time.
4. Haul routes are to be kept clean at all times. Failure to do so will be cause for revocation of this permit.
5. Applicant shall deliver one approved copy of this permit to the City of Carlsbad Police Department at 2560 Orion Way, and assure that one approved copy is in each truck assigned to the haul. One approved copy shall remain at the site(s).
6. Permittee shall indemnify, hold harmless, and defend the City of Carlsbad or its officers or employees from all claims, damage or liability to persons or property arising from or caused by any activity or work done pursuant to this permit unless the damage or liability was caused by the sole active negligence of the city or its officers or employees.
7. **Application for Permit shall be made at least two (2) working days prior to the proposed haul date(s).**
8. **Restricted hauling hours in a school zone.**

HAUL ROUTE PROCEDURES & REQUIREMENTS

DEVELOPER/PERMITTEE INITIATES REQUEST

A. REQUIREMENTS

- 1) Any haul of construction materials or equipment using more than three trucks or moving more than ninety (90) cubic yards of material through the city;
- 2) Any haul of materials or equipment, regardless of the number of trucks, causing disruption of the normal flow of traffic or requiring traffic control or pilot vehicle(s);
- 3) Any haul of materials or equipment, regardless of the number of trucks, when required by a Condition of Approval for a discretionary action;
- 4) Any haul of materials or equipment when, in the opinion of the city engineer, permitting is required for the public safety.
- 5) A copy of the permit shall be kept in the cabin of each haul truck and shown to the police or project inspector upon request.
- 6) It is the responsibility of the developer/permittee to post one copy of approved haul route at the job site and keep one copy in each truck assigned to the haul.

B. TO INITIATE A REQUEST

- 1) Submit Haul Route Application to 1635 Faraday Avenue, Carlsbad, between 8:00 a.m. and 4:00 p.m.
- 2) The project engineering inspector and construction manager will approve/sign the permit.
- 3) Permit must be applied for two (2) working days before the proposed haul date.
- 4) No fee is charged for a Haul Route Permit.
- 5) Note that all information including the project number and job location/address will need to be completed by the applicant prior to approval.

***NOTE: KEEP A COPY OF THE APPROVED PERMIT IN EACH VEHICLE AT ALL TIMES.**

THE CITY OF CARLSBAD RESERVES THE RIGHT TO REVOKE OR CHANGE HAUL ROUTE AT ANY TIME.

THERE WILL BE RESTRICTED HOURS OF HAULING WHEN ENTERING A SCHOOL ZONE.

HAULING OF MATERIAL ON SATURDAY, SUNDAY OR CITY HOLIDAY IS PROHIBITED.
