Public parking-build more parking structures or provide parking shuttles from local parks and parking lots. Make use of some of the open lots to create village parking. Viggaluccis vallet parking all the cars in the bike lanes is highly dangerous to our cycle community. Parks for kids- Our youth sports are having a very hard time finding field space to practice on, and our schools are having a difficult time maintaining the fields. I propose that our school fascilities be used for city park fields when school is not in session. For example, Sage Creek High School Soccer field, Could be used as a public field outside of school hours. The fields are very nice and need to be rented and maintained accordingly but it could be done. The extra revenue could be used for the school to maintain the fields, purchase phys ed equipment and suppliment more campus security. Or jefferson elementery cant afford soccer nets for the soccer goals on the field, If a Soccer club uses the field they would leave goals on the field for the school to use. Beach permits for special events- weddings, sports events, concerts, etc.. I believe there are many activities that could take place on the beach for our community. We need to make these permits more accessable to encourage special events in the offseason. AirBNB- As important as it is for property owners to make an income from their extra properties, those owners need to be sure they are respecting our neighbors. there should be a punishment for owners if the police are called to the properties. It is not fair for the neighbors to have to deal with noisy neighbors.
