Ms. Kelly,

Thank you for preparing NDC 101b, which unites people at the west end of Vancouver Street, east of the power lines, with their neighbors In Population Unit 6.

At the upcoming meeting this week, I will be making a couple of suggestions to tweak NDC 101b some more. My objective is to better assign a couple more little enclaves while leaving a bit more room for planned growth. I expect the districts will remain compliant, but perhaps you could prepare another iteration and let us know how these tweaks affect the balance.

1. Please move all of Population Unit 35 (~525 ppl) into District 1 from D2. This will put everyone North of the inflow to Agua Hedionda into D1.
2. Please move census blocks 132138 & 132141 (~276 ppl) to D4 fr D3. This will keep people who live south and east of the corner of Alga and El Camino Real with their neighbors west of the Omni La Costa north course.

Being able to show the actual map iteration would be ideal, but at least having visibility into the effect on the balance will be helpful in assuring us that these are viable moves.
