Regarding map 96973c, it appears that all 333 people in census block 124216 were moved to D4 from D2. At our January 27 meeting, Commissioner Ashton and I suggested that only the western portion of that census block be moved to D4 (the portion of the block that is NOT accessed from Xana Way). I assume that is possible. given that we are doing it in other places, e.g., along the coast and along the northern boundary between D1 and D2.) Splitting the census block would allow us to avoid splitting the gated neighborhood.

The district populations become more balanced for this map if the above split is incorporated. Just counting the houses, I estimate only ~39% of that population lives on the west side of the census block and should be moved. Hopefully you can determine better than I how many people would be involved.

Q: If you have time before Thursday's meeting, I'd appreciate it if you would prepare to tell us how many people would move if that split was made as originally requested. I'd also be curious how that would affect the population distribution among the districts.

In comparing the statistics for map 96973 vs those of **96973b**, I see differences of 1080 people in both D3 and D4. The populations of D1 and D2 remained the same. When I use the viewer to look at those two maps overlaid one on the other, I see only one change: Population Unit 100 has been moved from D3 to D4. The viewer indicates that Population Unit 100 has 1188 people. That implies 108 people went somewhere else. But I can't find any other change in the district boundaries. What am I missing?

Q1: Please be prepared to explain at Thursday's meeting why the delta differs from the population of unit 100, as shown in the viewer.

In comparing the statistics for map 96973 vs those of **96973c**, I see differences in three districts: D3 is lower by 1230 while D2 is up by 895 and D4 is up by 333.

- -- The D4 increase of 333 is presumably the result of moving all of census block 124216 into D4 from D2 (315 ppl per the viewer).
- -- The D3 decrease of 1230 appears to be the result of moving those parts of Population Units 64 and 71 that were in D3, just east of El Camino Real and north of Alga, into D2. (However, per the viewer, the affected census blocks contain 1423 ppl.)
- -- The D2 increase of 895 should be the net of the people moved in from D3 less those moved out to D4. Using the statistics, that would be 1230 333 = 897. (That math basically checks.) Using the viewer numbers, that net would be 1423 315 = 1107.
- Q2: Please explain why the Population Unit numbers can be used to calculate the changes in the 96973c statistics, whereas some other numbers must be used to calculate the changes in 96973b statistics.

O2a: What is the source of the latter numbers?

I note that the Population Unit numbers are not the sum of their census block numbers - they're often lower than the sum.

Q3: Does the viewer not have all the adjusted numbers? Again, please help me understand.

At the January 27 meeting, it was requested (by Commissioner Saldana?) that we be provided the numbers of people, and percentages, who will be moved from the existing districts to produce the new districts.

Q4: I hope to see that data at Public Hearing #4. I estimate that number to be around 25% for the versions of 96973.
