- California Orcutt's grass (Orcuttia californica) - FE
- Orcutt's brodiaea (*Brodiaea orcuttii*) – HCP Covered

- Riverside fairy shrimp • (Streptocephalus woottoni) - FE


#### Restoration of 2018 SANDAG Potholing

- Potholing for fiber optic line under SDGE gas line
- Careful soil removal and replacement
- Reseeding of potholing locations (approximately 20 square feet total)
- SANDAG funding provided to City of Carlsbad to conduct additional restoration and monitoring



#### Management and Monitoring 2019-present

- Monitoring of potholing
- Monitoring of preserve habitats and species
- Vegetation management by HRS
- Pothole locations successfully restored
- Increase in sensitive vernal pool species like spreading navarretia
- Spreading navarretia increase in plants from 50 to 500 individuals
